# 2. Data Controller and Data Protection Officer

### 3. Personal Data We Collect

We may collect and process the following categories of personal data:

- Identification Data: Your name, job title, and business address.
- Contact Information: Your email address and telephone number.
- Online Data: IP address, browser type, website usage data, and cookie information.
- Transaction Data: Information related to purchases or services you request from us, including billing and payment information.

After the relevant retention period has expired, we will securely delete or anonymize your data. You have the right to request the deletion of your data at any time, subject to legal obligations.

# 9. Your Rights Under GDPR

Under GDPR, you have the following rights:

- Right to Access: You can request a copy of the personal data we hold about you.
- Right to Rectification: You can request that we correct any inaccuracies in your data.
- Right to Erasure: You can request that we delete your personal data when it is no longer necessary for the purposes we collected it for.
- Right to Restrict Processing: You can request that we limit the processing of your data in certain circumstances.
- Right to Data Portability: You can request a copy of your data in a structured, machinereadable format to transfer to another service provider.
- Right to Object: You can object to the processing of your data for direct marketing purposes or on the basis of legitimate interests.
- Right to Withdraw Consent: You can withdraw your consent for data processing at any time.
